As of January 1, 2016, Marriage and Family Therapist (MFT) Interns in California are required to take the state's MFT Law and Ethics Exam in their first year of intern registration. Currently-registered interns need to take the test before their 2016 or 2017 renewals, depending on the intern's specific renewal month.
